

## ABSTRAK

### **TANGGUNG JAWAB DIREKSI PADA PELAKSANAAN GOOD CORPORATE GOVERNANCE (Studi pada PT.Bank Pembangunan Daerah Jawa Tengah)**

Perseroan Terbatas adalah badan hukum sebagai subjek hukum yang mempunyai harta kekayaan sendiri, dan Organ sesuai Undang-Undang Nomor 40 Tahun 2007. Organ Perseroan Terbatas adalah Direksi, Dewan Komisaris, dan Rapat Umum Pemegang Saham. Direksi dalam menjalankan pengurusan perseroan mempunyai tanggung jawab pada pelaksanaan prinsip *Good Corporate Governance* yaitu suatu proses yang diterapkan oleh manajemen perusahaan dalam menjalankan kegiatan operasional sehari-hari termasuk perbankan. Prinsip *Good Corporate Governance* yaitu: *Transparency* (Transparansi), *Accountability* (Akuntabilitas), *Responsibility* (Pertanggungjawaban), *Independency* (Kemandirian), *Fairness* (Kesetaraan dan Kewajaran). Contoh yang telah melaksanakan prinsip *Good Corporate Governance* adalah PT.Bank Pembangunan Daerah Jawa Tengah, namun didalam pelaksanaannya masih ada ketidakpatuhan yang dilakukan oleh pegawai.

Berdasarkan hal tersebut, penulis mengkaji dan menganalisis Implementasi prinsip *Good Corporate Governance* pada PT.Bank Pembangunan Daerah Jawa Tengah serta mengkaji dan menganalisis tanggung jawab Direksi PT.Bank Pembangunan Daerah Jawa Tengah terhadap hasil implementasi prinsip *Good Corporate Governance*.

Penelitian ini menggunakan metode pendekatan *yuridis normatif* dan metode wawancara sebagai pendukung yang bersifat *deskriptif analitis*, sumber dan jenis data menggunakan bahan hukum primer, bahan hukum sekunder, dan bahan hukum tersier. Teknik pengumpulan data adalah menggunakan penelitian kepustakaan (*library research*), selanjutnya data dianalisis secara kualitatif.

Hasil penelitian dari penulis bahwa Implementasi prinsip *Good Corporate Governance* pada PT.Bank Pembangunan Daerah Jawa Tengah yaitu laporan yang dipublikasikan berdasarkan prinsip Transparansi, Keseimbangan kewenangan antara Direksi, Dewan Komisaris dan Rapat Umum Pemegang saham berdasarkan prinsip Akuntabilitas, Mematuhi peraturan Undang-Undang berdasarkan prinsip pertanggungjawaban, menghindari dominasi dari pihak manapun berdasarkan prinsip Independensi, menjamin pemegang saham berhak atas deviden dan adil terhadap pegawai berdasarkan prinsip Kesetaraan dan Kewajaran. Direksi telah melaksanakan prinsip *Good Corporate Governance* sehingga menciptakan fungsi kepatuhan sesuai tanggung jawab Direksi.

## **ABSTRACT**

### **DIRECTOR'S RESPONSIBILITIES IN THE IMPLEMENTATION OF GOOD CORPORATE GOVERNANCE (A Study at PT. Bank Pembangunan Daerah Jawa Tengah)**

Limited Liability Company is a legal entity as legal subject having own assets and the organ is in accordance with Law No. 40 of 2007. The organs of Limited Liability Company are Directors, Board of Commissioners, and the General Meeting of Shareholders. Directors, in managing a limited liability company, have responsibilities in implementing the principles of Good Corporate Governance which is a process applied by the management of a company in performing its daily operational activities including banking. The principles of Good Corporate Governance include: Transparency, Accountability, Responsibility, Independency, and Fairness. The example of those who performed Good Corporate Governance is PT. Bank Pembangunan Daerah Jawa Tengah, However in the implementation employer still have not obey for their job.

Regarding the aforementioned above, the writer studied and analyzed implementation principle the Good Corporate Governance in the PT.Bank Pembangunan Daerah Jawa Tengah also to review and analysis responsibilities of the Directors PT.Bank Pembangunan Daerah Jawa Tengah for result implementation principle the Good Corporate Governance.

This research used the approach method of normative juridical and the interview as the supporting method which was analytical descriptive in nature. The source and type of data used primary, secondary, and tertiary legal materials. The data collection technique used library research, which was then analyzed in qualitative.

The writer's research results that the implementation from the principle of the Good Corporate Governance in the PT.Bank Pembangunan Daerah Jawa Tengah that is report is published based transparency principle, authority balance between Directors, commissioner and general meeting holder part based principle accountability, to obey law regulation based principle responsibility, avoid domination from side anywhere based principle independency, to ensure holder part have a right for dividend and fair to the employer based principle fairness. The Directors has implemented the principle of Good Corporate Governance to result to obey function suitable Directors responsibilities.
